#### Frequently Asked Questions

##### Does financial assistance cover the entire tuition for classes?

No. Woodlawn Arts Academy believes a strong sense of ownership and pride is developed when the recipient of financial assistance contributes to the cost of the program. Therefore, applicants will be asked to pay a portion of the fee for the requested services.

##### If I receive Woodlawn Arts Academy financial assistance, what is expected of me?

Regular attendance to any registered lesson or class is required. Financial assistance may be revoked or denied to anyone not regularly attending. Upon approval of assistance, an Academy representative mails verification and conditions of the assistance to you. Those conditions include the length of your assistance and the portion you will be asked to pay. We will keep the application on file for 60 days from the date of the application to allow for its completion. If you do not sign up for a program within these sixty days, you will need to reapply. It is the responsibility of the customer to monitor individual funds used.

##### How long will the financial assistance continue?

Financial assistance is usually good for one year. If there are special circumstances the assistance may only be applicable for three to six months. All participants must re-apply when the financial assistance expires.

##### Nondiscriminatory Policy

- Recent federal tax 1040 form (If you need one, contact the IRS at 800-829-1040.)
- Rent assistance, food stamps and any form of assistance
- Birth certificates/guardian papers for children NOT on taxes
- Two current paystubs for all working adults in household.
- Unemployment check, court-ordered child support or alimony payment.
- Social Security or disability checks.
- Transcripts of children over 18 attending college.
- If you have no forms of income, a letter from the person supporting you, such as shelter caseworker, parents or significant other, and one other letter or referral such as public aid or reduced-price lunch paperwork

## FINANCIAL ASSISTANCE POLICIES

- The maximum amount of financial assistance given to each applicant will be up to 70% of tuition.
- The sliding scale will be used.
- Most programs qualify for financial assistance. Assistance does not apply to drop-ins for yoga classes.
- Financial assistance may be used for only one private music lesson per session.
- No age limit for financial assistance recipients.
- Financial assistance is offered to all persons listed on this form. Additional family members may be added after the head of household has spoken to an Academy office staff member.
- A student who misses more than two lessons/classes per eight-week session or four lessons/classes per 16-week preschool semester could lose their time slot or spot in the class. A student who misses more than the allotted absences and is using financial assistance may be asked to pay additional program fees or may be asked to leave the program.

*I have read and understand the financial assistance policies listed above.
